- **1.** MEASURING THE EFFECT THAT UCC'S HAVE ON DEMAND/UTILIZATION OF THE ED FOR NON-EMERGENT CARE
- 2. DOCUMENTING DIFFERENCES BETWEEN RECEIVING CARE IN THE UC VS. AN ED
- **3.** DOCUMENTING TRENDS IN COMMERCIAL INSURER REIMBURSEMENT RATES
- 4. RURAL/MEDICAID OPPORTUNITIES
- 5. MEASURING THE EFFECT OF DIFFERENT OWNERSHIP MODELS IN URGENT CARE
